Key Themes and Takeaways

Throughout the event, participants explored high-impact topics including:

- Leveraging Technology and AI Tools for Association Effectiveness Leaders shared how artificial intelligence and automation platforms can streamline operations, enhance member engagement, and improve data-driven decision-making for state associations.
- Innovative Communication Strategies to Boost Engagement and Trust Attendees examined how associations can strengthen outreach by sharing customizable content, optimizing newsletters, and using tools like WhatsApp, CE21 forums, and social platforms to build stronger connections with members.
- **Demonstrating ROI and Member Value with Clear, Measurable Outcomes** Executive directors discussed methods for quantifying and communicating the financial and professional value of membership, focusing on outcomes such as advocacy wins, practice support, and education.

A central element of the forum was connecting with chiropractic students attending NUHS and reinforcing the value of early engagement in professional associations. Leaders highlighted that most state associations offer **free membership to students**, along with numerous benefits such as:

- Access to mentorship and networking within the chiropractic community
- Continuing education opportunities and professional development resources
- Support and advocacy on scope of practice and policy issues at the state level

These efforts are aimed at building a more connected, empowered, and future-ready profession.
